AFFIDAVIT IN SUPPORT OF WARRANTLESS ARREST

Your affiant, Investigator Mike Harris, has been a police officer for the past 35 years. Beginning in 1991 your affiant worked in the Crimes Against Children's Unit with the Lakewood Police Department. For the past 19 years, your affiant has worked as an investigator with the Jefferson County District Attorney's Office, assigned to the Crimes Against Children's Unit. Since October of 1996, your affiant has also investigated individuals who utilize the Internet to seek out children.

On October 18, 2014, I was online portraying a female teen under the age of 15. I was in a social networking site, sitting idle not participating in the chatroom communications. During this time I was sent an instant message from the screen name [REDACTED] (Martin). The initial message was "Hi there, you are beautiful and very sexy". This told me Martin had seen the teen persona's profile which showed the teen persona's pictures as well as her exact age "xx" which was under the age of 15.

On checking the profile for [REDACTED] I found the following:



Martin also posted the following pictures on his social networking site:



On seeing Martin was from Chicago I replied as the teen persona, "tooo bad ur tooo far though sorry lookin 4 peeps here but ty sayin hi". Martin replied back he would be in Colorado on Monday (October 20, 2014) and "I'd love to meet you!" Martin provided his phone number [REDACTED]

I next began to text Martin as the teen persona to the above phone number. On first contacting Martin via text message he replied his name was "Tony". Martin texted he would be working but he would be free in the evenings. Martin said he would get to Denver on Monday, October 20, 2014, and be here through the 31st. Martin said he was coming to train a new guy. Martin further stated "I like Petite girls" and "Yeah, keep Tuesday open, and every other day, lol! I'd love to meet you". Martin also texted, "I like drinking and making out. Your house or my hotel room". Martin said he was "7.5" to 8" big". Martin texted, "I think I do it all good. Kiss, lick but I think I fuck deep best" and "I like to not wear a condom and shoot my load deep inside too". Martin asked, "Ever try anal?" and "Just have to go slow for anal". Martin was told at this point the teen persona's exact age (under 15) to ensure the age of the teen was mentioned in text besides the teen's profile.

Martin sent the following picture through text:

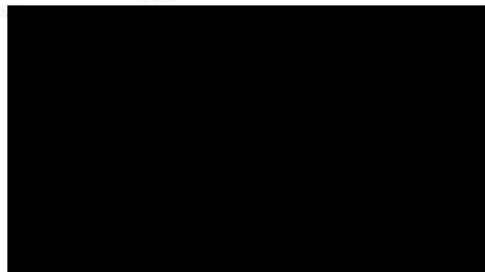


Martin sent a text asking, "Are you completely shaved bare?" The teen said she was shaved. Martin asked the teen persona if she liked guys or girls. The teen persona said, "like girls tooo only been with some my age". Martin replied, "That would be hot to see. Your age or younger, not older". Martin texted, "I like younger women. I'd marry one."

Martin texted, "I was lookin at ur pics. Makes me horny" and "Do you have any nude pics?" On saying yes Martin asked, "Send me some of you". Martin was told by the teen she didn't want to send them as then he not show up. Martin said, "Ok."

On October 18, 2014, Investigator Cassandra Harris developed information from Martin's phone number [REDACTED], which came back to Anthony Michael Martin, LKA [REDACTED] with a date of birth of [REDACTED].

Investigator Cassandra Harris further found on public Internet searches that Martin was the Vice President of the Morrison Security Corporation out of Chicago, Illinois. This company appeared to provide a varied amount of security nationwide. Martin was also found on the Morrison Security Corporation, YouTube video advertisement:

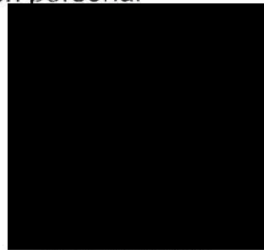


On October 19, 2014, Martin was asked by the teen persona, if he was "still down" to meet on Tuesday, and he said "Yup". Martin asked for the teen persona's address and he was provided it.

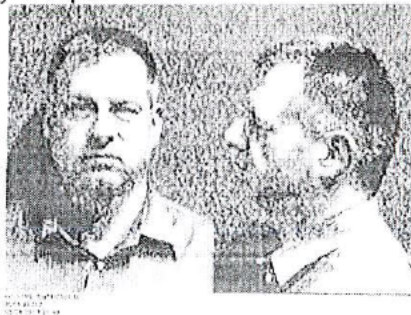
On October 20, 2014, Martin stated in a phone call with Investigator Cassandra Harris who was portraying the teen persona on the phone that he was in Denver, Colorado. Investigator Cassandra Harris had also spoken with Martin on October 19, 2014, at approximately 2027 hours.

On October 20, 2014, on checking NCIC for any arrests/criminal histories for Anthony Michael Martin (Dob: [REDACTED]), I found information showing he was arrested by Orland Park Police Department in Illinois for Indecent Solicitation of Child in August of 2013.

On October 20, 2014, I spoke with Detective Dawn Gorman-Kenny of the Orland Park Police Department who investigated the Indecent Solicitation of a Child Case with Anthony Martin. I sent Detective Gorman-Kenny the following picture which Martin had sent in communications with the teen persona:



After receiving the above photograph, Detective Gorman-Kenny told me that is Anthony Martin. Detective Gorman-Kenny told me the case she investigated, Martin had attempted to solicit an actual 14-year-old girl for sex. Detective Gorman-Kenny sent me Martin's booking photo in her case which on receiving was in fact the same person. Detective Gorman-Kenny also told me the phone number used in soliciting the 14-year-old in her case by Martin was the same one which was used in my case, [REDACTED]. Detective Gorman-Kenny also said that phone number was Martin's business cell phone number for Morrison Security Corporation.



On October 21, 2014, Martin had communicated in text message to the teen persona, "I wasn't messin' with you intentionally, but I'm not going to be able to meet you. Sorry". Due to concerns Martin had already solicited an actual 14-year-old teen in the Illinois case, I decided to contact Martin in the event he was talking with other underage children in the Denver Metro area to eliminate the chance of him meeting them in lieu of our teen persona.

On October 21, 2014, 1558 hours, I contacted Martin by phone and identified myself as a Detective Mike Harris. Martin admitted to talking to the teen persona, as well as talking about meeting the teen persona for sex. Martin further admitted to asking the teen persona for her naked pictures, but stated he didn't receive any pictures from her. Martin admitted to being in Denver, Colorado. Martin said at one point, "It was just idle chat". I didn't inquire any further and ended the phone call. This call was recorded.

On October 21, 2014, after talking with Martin I next contacted Morrison Security Corporation and requested to talk with [REDACTED] the CEO.
