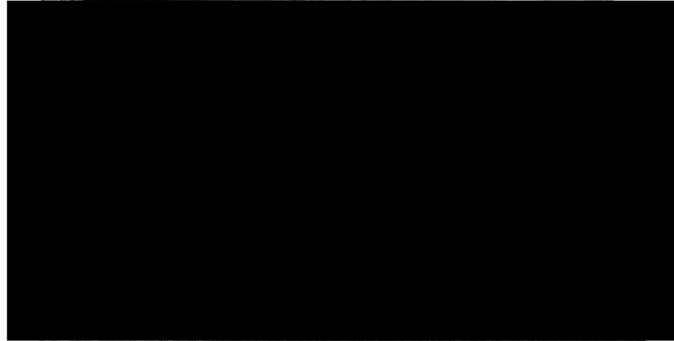


RESEARCH FOUND ON MARTIN'S PHONE NUMBER:

On October 18, 2014, Investigator Cassandra Harris developed information from Martin's phone number [REDACTED] which came back to Anthony Michael Martin, LKA [REDACTED].

Investigator Cassandra Harris further found on public Internet searches that Martin was the Vice President of the Morrison Security Corporation out of Chicago, Illinois. This company appeared to provide a varied amount of security nationwide. Martin was also found on the Morrison Security Corporation, YouTube video advertisement:



PHONE CALL – OCTOBER 19, 2014, 2027 HOURS:

On this date, Investigator Cassandra Harris portraying the teen persona over the phone, called Martin as he requested through text message. Harris told Martin on him answering she was [REDACTED] Martin said he wanted to hear her voice and make sure she wasn't some 20-year-old guy. Harris told Martin she was so excited and he said he was as well. Martin asked Harris if she had school all week and she said she did.

Martin asked Harris if she had done this before meeting guys and she said yes. Harris told Martin too bad her mom didn't go to work until Tuesday. Harris told Martin he sounded really sweet. Martin asked Harris if she drank and she said whatever she could get her hands on. Harris told Martin that it was easier to get weed, but she liked Captain Morgans and light beers. Martin said he liked beer and liquor. This ended this phone call. This call was recorded.

PHONE CALL - OCTOBER 20, 2014, 1448 HOURS

On this date, Investigator Cassandra Harris called Martin once again portraying herself as the teen persona, stating she had just got out of school and was waiting for her mom to pick her up. Martin asked her how school was and she stated it was ok. Harris told him she wanted to say hi real quick but her mom had arrived to pick her up. Martin said, "ok, hi and bye".

CRIMINAL HISTORY:

On October 20, 2014, on checking NCIC for any arrests/criminal histories for Anthony Michael Martin (Dob [REDACTED]), I found information showing he was arrested by Orland Park Police Department in Illinois for Indecent Solicitation of Child in August of 2013.

On October 20, 2014, I spoke with Detective Dawn Gorman-Kenny of the Orland Park Police Department who investigated the Indecent Solicitation of a Child Case with Anthony Martin. I sent Detective Gorman-Kenny the following picture which Martin had sent in communications with the teen persona:



After receiving the above photograph, Detective Gorman-Kenny told me that is Anthony Martin. Detective Gorman-Kenny told me the case she investigated, Martin had attempted to solicit an actual 14-year-old girl for sex. Detective Gorman-Kenny sent me Martin's booking photo in her case which on receiving was in fact the same person. Detective Gorman-Kenny also told me the phone number used in soliciting the 14-year-old in her case by Martin was the same one which was used in my case, [REDACTED]. Detective Gorman-Kenny also said that phone number was Martin's business cell phone number for Morrison Security Corporation.



PHONE CALL – OCTOBER 21, 2014, 1146 HOURS

On this date, Investigator Cassandra Harris called Martin again portraying herself as the teen persona and received his voice message. Harris left a message stating she was at lunch and she would try and text him.

PHONE CALL – OCTOBER 21, 2014, 1558 HOURS

On this date I called Martin after receiving his above text messages.

Q: Detective Mike Harris

A: Tony Martin

A: Hello?

Q: Tony, Mike Harris. How are you?

A: Hey Mike, good.

Q: The reason I'm calling you sir is I don't want to be contacting your superiors at your office. I'm a Detective Mike Harris and I've been looking through some phone transmissions and text message and stuff and I need to make sure we have one thing clear. That you are not going to meet this kid and you are going to cease all communications with this fourteen year old girl named [REDACTED]

A: I... Yes sir, I already did.

Q: Okay.

A: I realized what I was doing and I stopped and that's why she got upset.

Q: Well, I...

A: Because I told her wouldn't meet her.

Q: Well, that's fine. I mean I don't know why you would do something like this and jeopardize yourself but you need to... You know, use a little bit better judgment and I mean talking about meeting this fourteen year old girl and as you say "fucking her deep" and you like to lick and stuff. That ain't good-good sense sir. Okay?

A: I-I agree and that's why I told her I didn't want to... I agree absolutely. Advice well taken so...

Q: Well and you know, looking at the text you ask her for her naked pictures. To send them to you. If she would have do you realize how much trouble you would be in?

A: No, I guess I don't sir.

Q: You don't realize that asking a fourteen year old girl for her naked pictures...

A: Well, if I had them-if I had them on my phone I understand the implications of that. Yes sir, I do.

Q: Okay, it's just not real-real smart. I mean like right there in the state of Colorado is a class four felony sir. Asking a fourteen year old girl... Or asking any child under the age of eighteen for their naked pictures is a felony and that's nationwide because that's a Federal law as well. So, I mean I don't know why you would jeopardize your position at your company and do

something like this. It just (inaudible) me that you would put yourself in this position. You know?

A: Yes sir and really that's why I-I you know, I didn't. That's why I told her I didn't want to do anything. This is just getting out of hand. It was just supposed to be just idle chat and I...

Q: Sir, don't tell me it was idle chat. I mean you started out in Chat Hour and you said... Your screen name was [REDACTED] and then it says "I like young". So, I mean do you have a problem with kids sir? Are you attracted to kids?

A: No, I date younger women not kids. I date like 25-30 younger... Not young.

Q: Well sure but I mean this-this girl is I mean... Her profile... You saw her pictures. You comment on how beautiful she is. She even mentions in her texts that she's fourteen, that she's on the pill. I mean you know... Just-just not real smart. I guess what slays me is you know, that somebody would go to the extremes of talking to someone like that and jeopardizing their whole life. I mean you say, "I like younger" and you know you're talking to a fourteen year old. So, I... Don't tell me it was idle chat. I mean do you think this is... Your peers, your company if I showed them all this stuff. Showed them the text messages. I'm not...

A: Right.

Q: But if I did don't you think they would be appauled?

A: Yes sir, I do.

Q: Okay.

A: I absolutely do.

Q: Where are you anyway? Are you in fact in Denver?

A: Yes sir, I'm here I'm just trying to start up a new branch. I'm trying to hire a manager to this branch.

Q: Okay well I suggest while you are here if you want to meet a young lady, meet one for sex-meet one for sex but make sure they are eighteen or older. I don't care sir but leave the kids alone. Okay?

A: Yes sir, point well taken. Yes sir I am (inaudible)

Q: Okay, do you have a pen so I can at least give you my name and my phone number? Because I wanted to insure that I got this handled and that you would answer your phone so obviously I spoofed your work phone number. You ready?

A: Go ahead.

Q: Okay, it's Detective Mike Harris. H-A-R-R-I-S. I'm with the Jefferson County District Attorney's Office. My direct number is 303-271-6936.

A: Sir I got it.

Q: Okay sir, you know... You... I could just be saying, "You know what I'm going to get a warrant and blah blah blah but thank god you didn't meet this girl".

A: Yes sir, I agree and like I said your message is well received sir. I'm not going to do anything like that again.

Q: Okay sir, thank you so much.

A: Thank you.

Q: Okay bye.

ARREST:

On October 21, 2014, after talking with Martin I next contacted Morrison Security Corporation and requested to talk with Sean Morrison the CEO. On speaking with Mr. Morrison and explaining the above situation he advised me Martin was working in Denver, Colorado at [REDACTED] in Broomfield, Colorado on a project for the company. Mr. Morrison did not know where Martin was staying as his employees usually make their own hotel accommodations. I next googled the above address and began calling the nearest hotels asking for Tony Martin's room. On calling the 3rd hotel, [REDACTED] at [REDACTED] Broomfield, Colorado [REDACTED], and asking for Tony Martin's room I was put through to his room. I immediately hung up. This was at approximately 1650 hours.

We responded to [REDACTED] and met Broomfield Police and advised them of the above. I next called [REDACTED] and asked for Tony Martin. I was put through but there was no answer to his hotel room phone. This was at approximately 1720 hours. We next positioned ourselves in the Hotel in anticipation of Martin arriving at the Hotel during the evening. Due to Martin not being on scene Broomfield Police had to leave but advised us to call them if we needed assistance.

On October 21, 2014, at approximately 2250 hours, Martin still had not arrived at the Hotel. I decided to go and check the [REDACTED] address which was approximately 5 minutes from [REDACTED]. On driving through the parking lot there were a few cars in the parking lot. On driving completely around this address and coming back in front of the building we observed a male leaving from the front doors of the building. On using my binoculars I observed the male to be the same person in the above pictures, Anthony "Tony" Martin. Martin was contacted and arrested on the

above charges as he walked up to a, 2014, white Chevy Suburban with Colorado Fleet License Plate [REDACTED] in the parking lot.

On being arrested Martin immediately requested an attorney, even before having a chance to advise him of his rights.

Martin was jailed on the above charges.
